

URGE THE PRIME MINISTER TO HELP PEOPLE FLEEING WAR IN UKRAINE



The Russian invasion of Ukraine is a human rights catastrophe and a crime under international law. The UK government must do its part to help those fleeing the war.

Millions of people have fled Ukraine, seeking safety and refuge in neighbouring countries and beyond.

The Russian invasion of Ukraine has been marked by indiscriminate attacks on civilian areas and strikes on hospitals and schools. They've shown a blatant disregard for civilian lives, including children, by using ballistic missiles in densely populated areas.

The UK government has committed to provide sanctuary to some of those fleeing Ukraine, but the response has been slow, chaotic and doesn't go nearly far enough.

To add insult to injury, despite this humanitarian crisis and those in countries including Afghanistan and Syria, the government is still pursuing plans to penalise refugees entitled to asylum in the UK, through the Nationality and Borders Act.

The UK must act now - civilians who have fled the invasion and those still in Ukraine cannot wait.

IRAN: EXECUTION LOOMS FOR TORTURED ACADEMIC



Tortured Swedish-Iranian academic Ahmadreza Djalali, arbitrarily detained in Tehran's Evin prison, is at risk of imminent execution according to multiple Iranian state media reports that his death sentence for "corruption on earth" (efsad-e fel-arz) will be carried out by 21 May 2022 at the latest.(currently posponed yet again) He was sentenced to death in 2017 following a grossly unfair trial that relied on torture-tainted "confessions." The authorities must halt any plans to execute him and release him immediately.

On 16 May 2022, recognised Venezuelan human rights defenders Marino Alvarado and Alfredo Infante received notification of a defamation lawsuit filed against them by the governor of Carabobo state, Rafael Lacava. The lawsuit comes as a response to a report published in March by the NGOs Alvarado and Infant belong to, Provea and Centro Gumilla respectively, which exposes possible extrajudicial executions in Carabobo state and the lack of accountability enforced by the governor. This attack from the governor against Marino Alvarado and Alfredo Infante must end immediately, dropping the lawsuit and ensuring a safe working environment for human rights defenders.
